Open Space Quernmore Road - It was agreed that a letter be sent to the residents informing them of the change to the system and passing responsibility over to them

It was agreed to accept the quote from Heather Neesham for the maintenance of the War Memorial Gardens at a cost of £ 950 this year

Contract for cleaning bus shelters £18.50 per month.(same as last year) accepted from Lancaster City Contracts.

It was agreed to go back to Simply Clean for the Toilet Cleaning and request a reduced increase.

It was agreed that we did not want to be involved in the 'Delegated Services Pilot Project' (3 in Lancashire) and would wait and see any outcome for next year.
