10/255 OPEN SESSION

Eight members of the public attended to question the response of the Parish Council to the Planning Application for the Claughton Moor Wind Farm Project and why the Parish Council had not 'formally objected'. The position was explained and it was agreed that the Parish Council would take advice and then call an extra meeting to further discuss the matter. Comments on the Appeal had to be submitted by 24th November.

10/256 MINUTES OF THE PREVIOUS MEETING HELD ON 12th October 2010

The minutes of the previous meeting held on 12th October were confirmed and signed as a correct record.

10/257 POLICE AND COMMUNITY TOGETHER (PACT).

PC Wood reported that there had been a domestic incident (drugs related) and a male had been arrested. There had been an incident of egg throwing at a property on Quernmore Road and paint being poured over a vehicle in Artlebeck Road. The bullying of a resident on Fell View has resulted in a formal warning being given and Lead has been stolen off the roof of the Victoria Institute.

Crime in the whole Lune Valley is up by 50% over the last three months, mostly burglaries from farms. Speeding in the area is being targeted with the use of the laser gun on authorised sites. Security on the building site on Fell View was highlighted.

Cuts to the Police budget could result in the loss of Community Support Officers and the Parish Council was urged to write to the Chief Constable expressing concern.

The City and County Council are working together on the Winter Gritting Programme. Cuts to services are still to be finalised but it is likely PCSO's will be halved throughout Lancashire.

10/260 LENGTHSMAN, HIGHWAYS & FOOTPATHS

The Clerk reported that the Lancashire County Council Amenity Grass cutting system will change under 'delegated services' and looks likely that Lancaster City will take over responsibility in this district. Areas to be cut will be identified on maps which the Parish Council would like to see. It should not make a big difference to Caton/Brookhouse but the Parish Council were keen to maintain the same standard of service which we have arranged in the past.

It was agreed to tarmac the potholes on Station Road Carpark (£ 320), but delay the Double Yellow and White lines to Hornby Road (£ 400 minimum charge).

Replacement glass for Bus shelter will be arranged through Morecambe Bay Glass (£165). It was agreed that we accept the offer of crocuses for the green at Beckside.

Bus timetables – It was confirmed the new timetable be sited by the shelter in Brookhouse.

It was agreed to purchase a 15 ft tree (cost £180) for the War Memorial Gardens. The Play Park Action Group will organize an event to switch on the lights Saturday 4th December.

An order has been placed with Pennine Playgrounds and they plan to make a start on site mid November.

Play Builders Funding which was withheld in the summer has been reinstated which means we can include more equipment. Discussions are underway to extend the contract.

The project requires a CDM co-ordinator (Health & Safety legislation) to be appointed by the Client (us!). Chris Knowles, a local consultant has been approached and confirmation was given for his appointment. Cost £ 2,000 plus Vat to be included in the project costs.

Council agreed to the automatic transfer of funds to Pennine Playgrounds to pay their invoices. This is necessary as we will be working on a tight timescale from receipt of invoice, claiming of funds from others and paying the invoice (30 days). The paid invoices etc. will be reported to each Parish Council meeting.

As from next year Lancaster City Council will be undertaking four inspections per annum and will perform up to £ 100 worth of repairs at no cost to the Parish Councils.
